- 1) A duly called, posted Meeting was called to order at 1:02 P.M. by the Chairman.

- 2) Christopher Pilla moved to approve the minutes of the September 19, 2023 meeting – Second by Richard Villani – Vote Taken 3-0 (2 abstentions).




