##### **III. Review with Skatepark group for possibilities of a park in town**

Vernon Grove Park as a possible space for the Skate Park, as well as Tank Field, Community Garden, Louisa Lake, and Asylum Street. Need to add to the feasibility study. Ideal location would be Vernon Grove. Committee would like it at Fino field, especially Votolato field. They like it because of the proximity to parking and schools. Town Park can't be used due to the grant already being proposed.

##### **VI. Other Business- Commissioners Request- Public invitation to speak**

Jim Patel would like to talk about using the Annex for a cricket field. The robot Paint machine measured out the area and it would fit. He was hoping they could host tournaments for the cricket league. Repairs and building of the court would be the responsibility of the league, Season May through September Saturday and Sunday. Jim will look at the schedule and put some stuff together for him and will need to look into possibilities.


