**Election Date – Tuesday April 4, 2017** \**(1<sup>st</sup> Tuesday in April)*

**Nomination papers become AVAILABLE-** Mon., Jan. 9, 2017 at 8:30 am (Town Clerk's Office)

**50 (or more, legible) signatures** of **any** Registered Voters in Milford are required *for all Elected Officials* positions & **30 (or more) signatures** of Registered Voters **within your OWN precinct** are required for all **NEW** Town Meeting Member positions. (\***Incumbent** Town Meeting Members are **required to complete an affidavit of reelection** to be placed again on ballot)

**Last day to OBTAIN** Nomination Papers- **Feb. 13<sup>th</sup> by 5:00 pm** (Town Clerk's Office)

---

**Last day to SUBMIT Nomination Papers** to Board of Registrars for certification-  
**Feb. 15<sup>th</sup> by 5:00 pm** (Town Clerk's Office)

---

**Last day to FILE** Nomination Papers with Town Clerk-**March 2<sup>nd</sup> by 5:00 pm** (Town Clerk's Office)

---

**Last day to WITHDRAW** Nominations- **March 6<sup>th</sup> by 5:00 pm** (Town Clerk's Office)

---

**Deadline to REGISTER to Vote-** **March 15<sup>th</sup> by 8:00 pm by 8:00 pm** (Town Clerk's Office)

---

**Last day to POST WARRANT(s)-** **March 28<sup>th</sup> by 5:00 pm** (10 or more public places)

---

**Election Day hours & Polling Locations-Tuesday Apr. 4<sup>th</sup> polls will be open 8:00 am-8:00 pm**

(Precincts 1 & 6- Sr. Center 60 North Bow St)

(Precincts 2 & 3 -Italian Vets Hall- 4 Hayward Field)

& **ON OR BEFORE January 20, 2018 by 5:00 pm** for the "Year End" (dated 5/5/17 thru 12/31/17)
